

# United States Regional Privacy Notice

**Last updated: December 2025**

This United States Regional Privacy Policy (“US Notice”) supplements our Privacy Policy & Cookies. This US Notice is for individuals residing in certain US states, including New York, Virginia, Colorado, Connecticut and Utah, and is designed to help you better understand how we collect, use, and disclose your personal information and, depending on where you reside, how to exercise your rights under state privacy laws in the US (“State Privacy Laws”).

If you are a resident of California, please refer to our California Consumer Privacy Notice, below.

Please note that the rights listed below may be limited to residents of the states listed above, and may not be available to all users.

## 1. Your privacy rights

The State Privacy Laws may provide residents with some or all of the rights listed below. However, these rights are not absolute and may be subject to certain exceptions. Therefore, we may decline your request in certain cases as permitted by law.

- **Right to Know:** You can request the following information about how we have collected and used your personal information:
  - the categories of personal information that we have collected;
  - the categories of sources from which we collected personal information;
  - the business or commercial purpose for collecting, disclosing and/or selling personal information;
  - the categories of third parties to whom we disclosed personal information;
  - the categories of personal information that we shared or disclosed for a business purpose;
  - and the categories of third parties to whom the personal information was sold or disclosed for a business purpose. While we do not sell your personal information for monetary compensation, some states consider sharing of personal information for targeted advertising a “sale” or “share” under the State Privacy Laws.
- **Right to Access:** You can request a copy of the personal information that we have collected about you.

- **Right to Amend:** You can ask us to correct any inaccurate personal information that we have collected about you.
- **Right to Delete:** You can ask us to delete the personal information that we have collected about you, as long as any of your personal information in our records is not subject to any of State Privacy Laws exceptions.
- **Right to Opt Out of certain processing activities:** You can ask to restrict or stop the processing of your personal information in certain contexts, such as if we process personal information that is considered “sensitive” under applicable state laws or engage in certain automated decision-making activities.
- **Right to Opt Out of targeted advertising:** Targeted advertising is the practice of serving you tailored advertisements based your personal information gathered across other businesses, websites, applications, or services. You have the right to opt out of this practice. For more information about our targeted advertising practices, please refer to the “*Cookies*” section of our Privacy Policy & Cookies.
- **Right to Non-discrimination:** We will not discriminate against you for exercising any of your rights, including denying you goods or services, providing you with a different level or quality of services, or charging you different prices or rates for services.
- **Right to Appeal:** In certain states, you may have the right to appeal our decision regarding a request related to these rights. If you wish to appeal a decision, please contact us via our [Privacy portal](#), or contact our [Customer Service](#).

## 2. Exercising your rights

## 3. Verification; Authorized agents

We may need to verify your identity in order to process your right to know, access, appeal, correction, or deletion requests. We may need to confirm your residency, and in our discretion, we may deny your request if we are unable to verify your identity or residency. As a part of this process, identification may be required.

You may designate an authorized agent to make a request on your behalf. In order to designate an authorized agent to make a request on your behalf, you must provide the end user’s valid government-issued identification, and the authorized agent’s valid government-issued identification, and we may verify the authenticity of the request directly with you.

#### **4. Important information on identity checks**

For compliance purposes, to fight fraud and/or to investigate suspicious activity, we may ask you for proof of identity, address, purchase/sale or bank card. We will tell you how to provide us with these documents so that only the information we strictly need is transmitted to us (e.g.: copy of the identity card, photograph of part of a document, etc.). Only the departments that need to see these documents will process your data. We only keep these documents for the time necessary to verify them and then delete them immediately.

### **California Consumer Privacy Notice**

This California Consumer Privacy Act Notice ("CCPA Notice") is a supplement to our Privacy Policy & Cookies and applies to personal information Vestiaire Collective collects online about California consumers.

This California Notice uses certain terms that have the meaning given to them in the California Consumer Privacy Act of 2018 (as amended by the California Privacy Rights Act of 2020) and its implementing regulations (collectively, the CCPA).

For the purposes of this California Consumer Privacy Notice, "personal information" is defined as information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular California consumer or California household.

#### **1. How we collect, use, and share personal information**

Vestiaire Collective may collect personal information from you in different ways and for different purposes. It is important to note that the types of personal information we collect will depend on your interaction with us, including the types of products or services you use.

This section contains the categories of personal information that we may have collected in the last twelve (12) months and for each category of personal information, the categories of third parties with whom personal information is shared for a business purpose.

#### ***Personal data collected; sources and purposes of our collection***

We obtain the categories of personal information listed above from you directly, but also from third parties who want you to benefit from our services, advertising partners and social networks depending on the authorizations you provide them directly.

On our Platform, the mandatory nature of the data to be provided is indicated to you at the time of collection (for example, by an asterisk). If you do not fill in the mandatory fields, we will not be able to provide you with all our services.

You will find in section 2 of our Privacy Policy & Cookies (*"Personal data collected on the Platform"*) a list of all the data that we may have collected and processed about you in the preceding twelve (12) months, depending on your use of the Platform and the authorizations you provide.

To know for what purposes we may use your personal information, please refer to the section 3 (*"Processing that we carry out to execute pre-contractual measures and our General Conditions"*), section 4 (*"Processing that we carry out on the basis of our legitimate interests"*), section 5 (*"Processing we carry out only with your consent"*) and section 6 (*"Processing we carry out to comply with our legal obligations"*) of our Privacy Policy & Cookies.

### ***Sale or sharing of personal information; disclosure of personal information for a business purpose***

We **do not sell your data for money**. We do share your data with certain third parties such as online advertising services, which you have the right to opt out of.

We may need to **disclose your data**, such as to other companies that are in our group of companies, to third parties that provide us with services, or for legal reasons.

We do not knowingly sell or share the personal data of minors under 18 years of age.

## **2. California Consumer Privacy Rights**

You have the right to send us a request, no more than twice in any twelve-month (12) period, for any of the rights detailed in the *"Exercising your rights"* section of our US Notice and Section 12 (*"Your rights"*) of our Privacy Policy & Cookies, in the period that is 12 months prior to your request date.

Please note that personal information is retained by us for various time periods, so we may not be able to fully respond to what might be relevant going back 12 months prior to the request.

If you are a California resident and you or your authorized agent wish to submit a request to exercise your consumer rights under the CCPA or if you have questions

### **3. Response timeline**

We will respond within forty-five (45) days of receiving your request. In certain circumstances, we may require additional time and will notify you within the initial 45-day period if an extension is necessary.
